Re: Public Record Request

Dear Mr. Brister,

Pursuant to the Mississippi Public Records Act, Miss. Code Ann. § 25-61-1 *et seq.*, I request a copy of the following public record:

**The list of all felony defendants being held within the county for trial, grand jury action, or extradition for the term of court beginning the 2nd Monday of March required by Rule 8.5(c), the list should include each defendant's name, the charge(s) upon which he or she is being held, and the date he or she was most recently taken into custody.**

Rule 8.5(c) states, in pertinent part, that:

No later than seven (7) days before the commencement of each term of circuit court in which criminal cases are adjudicated, the official(s) having custody of felony defendants being held for trial, grand jury action, or extradition within the county (or within the county's judicial districts in which the court term is to be held) shall provide the presiding judge, the district attorney, and the clerk of the circuit court the names of all defendants in their custody, the charge(s) upon which they are being held, and the date they were most recently taken into custody.

Moreover, the commentary to Rule 8.5(c) provides that "[t]he clerk of the circuit court shall maintain the lists required by section (c)."

The requested public record may be provided to me in electronic or paper format. I am willing to pay costs and fees for responding to this request up to a maximum of \$20.00. If you

estimate that the fees will exceed this limit, please inform me before complying with this public record request. I can be reached by telephone at (228) 357-2112 and by email at [bewarne1@go.olemiss.edu](mailto:bewarne1@go.olemiss.edu). Please send the records and invoice to me by email, or by mail at 481 Chucky Mullins Drive University, MS 38677.

Where exemptions to the Public Records Act are discretionary, I ask you not to withhold such records, even if they might qualify for withholding under the law. If you withhold any records as exempt, please redact the exempted portions and release the remainder of the records as required by Miss. Code Ann. § 25-61-5(2). If you withhold any records, please explain in writing the basis for withholding the records. *See* Miss. Code Ann. § 25-61-5(3).

If you have any questions regarding my request, please contact me by telephone or email rather than by mail. I look forward to your reply as soon as is practicable, **and no more than 7 working days from your receipt of this request.** *See* Miss. Code Ann. § 25-61-5(1)(a).
