On February 15, 2018, our office sent you the Mississippi Public Records Act request attached hereto. Despite your statutory obligation to respond, we have not yet received the requested documents or an explanation as to why you believe the documents are not subject to production. We sent similar requests to circuit clerks throughout Mississippi, and the vast majority have complied.

In the interest of avoiding litigation, we will give you until March 9, 2018 to produce the requested documents. If you have any questions about our request, I am happy to discuss the matter with you. Please feel free to contact me at the phone number or email address provided above. Should you fail to comply with our request by March 9, we will seek a court order requiring you to do so. We also will seek attorney's fees and costs incurred as a result of your failure to comply with the Mississippi Public Records Act.
