1 THE COURT: Today is May the 1st of 2018
2 in Tishomingo County. This is the first week
3 of a two-week term.

4 Last Friday I instructed them to pull a
5 jail list, which I went over pursuant to the
6 new rule that the Court shall look and see
7 anybody that's been in jail for more than 90
8 days and make a determination as to why
9 they're there to speed the process.

10 I have obtained a jail list and there's
11 seven on the list that appear to have been in
12 jail more than 90 days.

13 Jessica Morris is represented, I have
14 determined, by Mr. Tyler Moss. It is set for
15 Wednesday, May the 2nd. Mr. Moss is supposed
16 to be here and he thinks he has it worked
17 out.

18 Number two is Robert Hood represented by
19 Clay Nails. And that is set for May the 7th,
20 Monday of next week. Mr. Nails is coming
21 tomorrow to hopefully work it out.

22 Jonathan Hamm, I believe is here, and I
