On or about March 20, 2019, our office sent your office a Mississippi Public Records Act request. Despite your statutory obligation to respond, we have not yet received the requested documents or an explanation as to why you believe the documents are not subject to production. We sent similar requests to circuit clerks throughout Mississippi, and the vast majority have complied.

In the interest of avoiding litigation, we will give you until April 24, 2019 to produce the requested documents. If you have any questions about our request, I am happy to discuss the matter with you. Please feel free to contact me at the phone number or email address provided above. Should you fail to comply with our request by April 24, we will seek a court order requiring you to do so. We also will seek attorney's fees and costs incurred as a result of your failure to comply with the Mississippi Public Records Act.
